## Important Notice Regarding Visiting Australia for the 24th ICID International Congress

Early Bird Registrations Closing Soon – 1st of July 2022

## Are You Visiting Australia for the ICID 24th Congress?

If you are attending or planning to attend the ICID 24th International Congress in Adelaide in October 2022, then we have some important information for you.

Travellers to Australia are experiencing lengthy delays obtaining visas to enter Australia, this is a result of our borders opening after the pandemic.

We strongly recommend that you start the visa application process as soon as possible and the link below will take you to the Australian government website that contains the information needed to complete your visa application.

All visitors to Australia must have a valid visa to travel to and enter Australia (other than New Zealand passport holders who will normally be granted a Special Category visa on arrival). It is your responsibility to ensure documentation is correct and completed before you commence your journey. Delegates must register and complete full payment for the event before lodging their visa application.

Before lodging an application, you should determine which visa you should apply for. The Australian Government Department of Home Affairs "Find a Visa" (https://immi.homeaffairs.gov.au/visas/getting-a-visa/visa-finder) tool has the latest information on applying for a visa to visit Australia.

- Select the first option "Visa & Tourism" and then "Attending a Conference or Expo" you will then be asked to enter your country of passport.
- This will then have the requirements for your nationality including the fees that will apply.
- You can then select the details button to proceed to the application stage.
- if you are not vaccinated against COVID-19 it is still possible to enter Australia but you will have to provide a medical certificate detailing why you cannot be vaccinated. If you have questions regarding your visa you can seek assistance at this link (https://immi.homeaffairs.gov.au/help-support/who-can-help-with-yourapplication/overview) there is no fee for this service. 

#### ICID Initiative for a Global Inventory of Irrigation and Drainage Schemes



#### **Need a Global View**

Irrigated agriculture forms the kingpin of the food and water security of the country and the region. Systematic irrigation is practised through irrigation projects of various sizes, which provide the assured source for a sustainable and timely water supply. Thus, an irrigation project forms the atomic unit of irrigation and water resources development. Across the world, irrigation is practised under varying agroclimatic conditions and topography and area appropriate solutions for the same determine the features of individual irrigation projects.

A global view of the irrigation and drainage projects provide great insights into various development approaches followed across the world, their success and their performance. It is observed that the topographic, hydrologic, agronomic and social conditions form a unique combination in which an irrigation project gets planned and implemented. Hence, there is a need to have a global view of the developments which show us the measures adopted and their contexts under a multi-dimensional environment. Attempts are made by various

researchers and practitioners to examine specific issues but examination of a project as a whole in a global context requires a repository of information through which the individual projects of interest can be visualized and approached for lessons.

ICID is the only major international scientific and technical organization that, through its membership network, spans across more than 90% of the irrigated areas of the world. The necessity for having a global view of projects devoted to irrigation and drainage is greatly felt by the member countries and also across the world by various agencies. ICID has, therefore, taken initiative to collect and provide a community knowledge base of irrigation and drainage projects which can work as a common pool resource for understanding the status of development and approaches used for the development and management project under varying conditions.

## Setting up a Register of World Irrigation Schemes

Various registers exist in the field of engineering structures and other entities,

the most notable from the water resources angle being the World Register of Dams being maintained by the International Commission on Large Dams (ICOLD). ICID is also maintaining a World Register of Heritage Irrigation Structures and awards recognition to the structures meeting the eligibility criteria.

Most registers examined are about structures and individual components of a system and none recording the features of irrigation and/or drainage project on a worldwide scale. It is, therefore, felt that such a register should be established for irrigation projects and ICID being a key player in the fields of irrigation and drainage is the most suitable agency for the establishment of a Register on "World Irrigation Projects". The authenticity of the projects in the register will be obtained through ICID National Committees

The facility is presently located at www. icidevents.org/WorldIrrPrjs/ Default.aspx and is in the development phase. At the appropriate time, once a critical mass of data is available, the same will be migrated to a dedicated domain duly registered.

#### **Outcomes of the 4th Asia-Pacific Water Summit (APWS)**

Asia-Pacific Water Forum (APWF), which Japan Water Forum conducts the secretariat, and Kumamoto City successfully organized the 4th Asia-Pacific Water Summit (APWS) on 23 (Sat)-24 (Sun)April 2022 under the theme of "Water for Sustainable Development: best practices and the next generation."

The APWF Secretariat discussed with the experts and practitioners of domestic and international organizations several times what is necessary for the Asia-Pacific region to recover from the Covid-19 by addressing water issues and a complex array of related problems to enable sustainable development over the next generations. We then achieved the consensus and defined quality-oriented growth as the growth that satisfies all three factors: (1) Resilience to the meteorological phenomena, flood, and drought intensified by chancing climate, maintaining or restoring a sound water cycle; (2) Inclusiveness, ensuring that no one will be left beyond, irrespective of gender, including the poor and socially vulnerable,

in access to safe water and sanitation, as well as food and nutrition, measures to water-related disasters and water resources management; and (3) Sustainability to protect and maintain social activities and environment. We also made the framework of discussion to promote the necessary measures from both structural and non-structural measures to realize the quality growth in Asia and the Pacific through the opportunity of the 4th APWS. Below I share the results of each of the 4th APWS programs.

In the HSG meeting, Japan's Prime Minister Fumio Kishida launched the Kumamoto Initiative for Water. He declared that Japan would commit to leading the implementation of measures to develop quality infrastructure by making use of Japan's advanced technologies, thereby simultaneously contributing to addressing water and the social issues and sustainable economic development in the Asia-Pacific region, centering on two approaches: (1) implementation of

measures for climate change adaptation and mitigation, and (2) measures to improve people's basic living environments. He also announced that Japan would provide financial assistance worth approximately 500 billion yen (nearly 4 billion dollars) over the next five years to the Asia and the Pacific region.

The UN Conference for the Midterm Review of the Water Action Decade will be held in March 2023 at the UN Headquarters, which focuses on water for the first time in 46 years since the one in Mar del Plata in 1977. The Japan Water Forum will disseminate the Kumamoto Declaration, the 4th APWS Chairs Summary, and "Showcase and Roadmap for quality-oriented growth in Asia and the Pacific," which summarize the wisdom and recommendations of the Asia-Pacific region. We will continue to work with various policymakers, experts, and practitioners in Japan and overseas to contribute to resolving water issues in the Asia-Pacific region and the world
